Question 1

Emergency Risk Protection Order or 'Red Flag' laws would allow judges to order the confiscation of a citizen's firearm(s) based on hearsay evidence, in court hearings where the accused may not even be allowed to testify on their behalf. In practice, these laws create a process to strip away a citizens' firearms and rights who have not been convicted of any crime with no due process and no ability for them to defend themselves in court of law - as we have seen in states like Indiana, Florida and even attempts to pass them here in Tennessee.

If elected, would you oppose any Emergency Risk Protection Order or 'Red Flag' gun law that violates due process rights, strips gun owners of their Second Amendment freedoms, and does nothing to stop violent criminals?

Question 2

Tennessee's preemption statute (T.C.A. § 39-17-1314) is intended to keep local governments from passing rogue gun control. However, the Memphis City Council willfully violated state law by attempting to place a sweeping local handgun and "assault weapon" ban on their municipal ballot, which was only stopped after a costly lawsuit in November 2025.

If elected, would you sponsor or cosponsor legislation that establishes personal civil fines, loss of public funding, and cause-for-termination penalties for any local official or municipal administrator who knowingly votes for or enforces a local firearm ordinance in violation of state preemption?

Question 3

Extreme Risk Protection Orders (ERPOs), commonly known as "Red Flag" laws, allow judges to order the confiscation of a citizen's firearms based on hearsay evidence, often without a prior hearing where the accused can defend themselves. While Governor Bill Lee signed legislation in 2024 to block local municipal red flag laws, the threat of state-level or federal-backed red flag policies remains.

T.C.A. § 39-17-1311 historically prohibited carrying firearms in public parks, playgrounds, and civic centers. Although the August 2025 court ruling struck down this location ban as unconstitutional under the Second Amendment, the ban remains in the written statutes.

In the 2026 legislative session, the General Assembly passed SB 350 to prohibit landlords from placing lease restrictions on a tenant's right to possess, carry, store, or transport firearms on leased premises. However, public housing authorities and private corporate landlords continue to seek loopholes to disarm vulnerable Tennesseans.

If elected, will you cosponsor and vote yes on legislation to strengthen and expand SB 350, ensuring that no landlord or housing authority in Tennessee can ever deny a tenant their constitutional right to keep and bear arms for self-defense inside their home?

Question 7
